**SECTION 2 - HAZARDS IDENTIFICATION**

**EMERGENCY OVERVIEW:**

**POTENTIAL HEALTH EFFECTS:**

• **Eye:**

Water, Ammonium Lauryl Sulfate, Ammonium Laureth Sulfate, Cocamide MEA, Glycol Distearate, Dimethicone, Cetyl Alcohol, Fragrance, Polyquaternium-10, Sodium Citrate, Sodium Benzoate, Disodium EDTA, PEG-7M, Citric Acid, Hydrolyzed Silk, Simmondsia Chinensis (Jojoba) Seed Oil, Oryza Sativa (Rice) Bran Oil, DMDM Hydantoin, Ammonium Xylenesulfonate, Sodium Chloride

### SECTION 4 - FIRST AID MEASURES
